Subject: Local Issuing Authority requirement for Tertiary Permittee Notice of Intent (NOI) on Common Development single lot development.

In December 1999, EPA finalized the "Phase II" regulations, which require controls on storm water discharges from municipalities, industries, and construction sites. Specifically, construction sites disturbing equal to or greater than one acre to control pollutants in stormwater runoff.

Construction activity disturbing less than one acre requires a permit if it is part of a larger common plan of development or is individually designated for permit coverage by the National Pollutant Discharge Elimination System (NPDES) permitting authority.

The Environmental Protection Agency has certified the State of Georgia, through the Department of Natural Resources, Environmental Protection Division to issue, locally, NPDES permits for Stand Alone Construction, Infrastructure Construction, and Common Development sites. Common Developments that have undergone final stabilization, filing a Notice of Termination, or have ceased development for a minimum of 90 days shall be affected by NPDES permits filed after August 1, 2000. Since August 1, 2000, Carroll County has 44 Common Development sites that remain with undeveloped lots. Under federal guidelines delegated to the State and further to the Local Issuing Authority (Carroll County) these Common Developments shall require individual lot Erosion Sedimentation and Pollution Control Plans prior to issuing a building permit for development. The building permitee shall file a Notice of Intent with the State as a Tertiary Permittee with no additional fees due to the State.
