For long-term rentals, the Director of Recreation will establish an appropriate fee. All rentals are subject to availability on a first come-first served basis, and will always yield to recreation activities.

- Some rentals may require a deposit
- 10% of any fee(s) are subject to forfeiture rain or shine due to staffing, utilities, equipment and other costs associated with every rental.
- Alcohol is PROHIBITED on recreation property.
- Use of tobacco and vaping is prohibited.
